The appointees figuring at S.No. 01 & 2 shall report to Directorate of Employment, J&K 38-A Samunder Bagh Exchange, Road Srinagar and S.No. 3 Shall report to the Directorate of Employment, J&K 2nd Floor, Auqaf Complex, Gandhi Nagar, Jammu within a period of 21 days from the date of issuance of this appointment order. In case of failure of any of these appointee(s) to join within the stipulated period, his appointment shall deemed to have been cancelled without any further notice.

The appointment of the above candidates as " Career Counselling Officers" shall be governed by the terms and conditions as laid down under SRO-202 dated 30.06.2015.

A) The appointee(s) shall be allowed to join only on production of the following certificates in original:

- Academic/Technical Qualification Certificates.
- Matriculation /Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.

- iv) Permanent Resident Certificate issued by the Competent Authority.
- v) Certificates from the District Industries Centre (DIC), and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee(s).
- vi) Relevant category certificate.
- B) The appointment of above candidate(s), as Career Counselling Officer in the Employment Department shall further be subject to the following conditions:-
- i) Each appointee shall give an undertaking to the effect that in case adverse report about his Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, He shall have no right to claim his appointment as Career Counselling Officer and his appointment, as such, shall be deemed to have been cancelled ab-initio;
- ii) Verification / genuineness of the qualification, reserved category certificates and recognition of the Institutes from the concerned issuing authorities.
- iii) The salary of the appointee(s) shall not be drawn and disbursed unless the satisfactory reports as detailed at (A) and (B) above are received in their favour.
- iv) The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by these appointee in the selection list prepared by the J&K Service Selection Board.
- v) The appointment shall be subject to outcome of the writ petition (s) if any, pending before Competent Court of Law.
