In pursuance to the approval conveyed by the Administrative Department vide letter No. LE-Genl/67/2021-11-L&E dated: 03.04.2023 and on the basis of selection made by J&K Service Selection Board conveyed vide letter No. JKSSB-PLAN/25/2022-03 dated: 16.03.2023 and in continuation to this office order No. 134-ED of 2023 dated: 16.05.2023, order No. 144-ED of 2023 dated: 05.06.2023, Order No. 153-ED of 2023 dated: 12.06.2023 and 156-ED of 2023 dated: 20.06.2023, sanction is hereby accorded to appointment of Mr. Pawan Kumar S/O. Mulkh Raj R/o.H.No. 01, Ward-07, Treli Gagwal, Samba as Junior Assistant (under OM category) in the J&K Employment (subordinate) service in the Pay Level-4 (25500-81100) with immediate effect.

The appointee shall report to Assistant Director Employment, District Employment & Counseling Centre, Ramban within a period of 21 days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:

- i. Academic/ Qualification Certificates.
- ii. Matriculation/ Date of Birth Certificate.
- iii. Health certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile certificate issued by the competent authority.

The appointment of the above candidate shall further be subject to the following conditions:

a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/ Date of Birth certificate and relevant category certificate (if any applicable), are found fake/ forged after getting the same verified from issuing authorities, his appointment as Junior Assistant in the J&K Employment (Subordinate) Services shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- b. That if the candidate has taken loan for Self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of Unit/ enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a selfemployment unit/enterprise and recovery to be made and also personally monitor its recovery.
 - c. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/ Date of Birth/ Relevant category Certificate is received from the concerned Authorities/ Agency.
 - d. The appointee shall be on probation for a period of two years.
 - e. The appointment of the candidate shall be governed by the "NEW Pnsion Scheme" as notified vide SRO-400 of 2009 dated: 24.12.2009.
 - f. The inter-se-seniority of the appointee in the J&K Employment (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
 - g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of Law.
