Subject: Cancellation of appointment of Junior Assistants.

WHEREAS, on the recommendation of J&K Services Selection Board vide No. SSB/Sel/Secy/04/2019/131-37 dated 08.01.2019 and the approval conveyed by the Administrative Department vide No. L&E/Emp/10/2013 dated 25.02.2019, thirteen (13) candidates were appointed as Junior Assistants in the Employment Department vide Order No: 65-ED of 2019 dated: 06.03.2019;

AND WHEREAS, All the appointees were intimated through registered post to report to the Directorate of Employment, 2nd Floor Auquaf Complex, Gandhi Nagar, Jammu within a stipulated period of 21 days from the date of issuance of order;


