3. Category Certificate, if any, issued by the competent authority.
4. Qualification Certificates.
5. Character Certificate.
6. No Demand Certificate from concerned DE&CC & DIC.
7. Medical Certificate.

Further, the salary of the appointees shall be drawn and disbursed only after the receipt of the Character and Antecedents verification report from the verifying agency. In case, any appointee is adversely reported upon by the verifying agency i.e. CID, he/she shall have no claim to hold the post and the appointment shall stand automatically cancelled without any further notice. It is further ordered that the Salary of Chewang Rinchin, Head Assistant, DE&CC, Leh shall be drawn against the available vacant post of Junior Stenographer henceforth.

The Employment Officers shall resume their training at IMPA&RD, J&K, Jammu/Srinagar immediately after their joining at their respective place of postings.


