House No. 230, Narwal Pain, Dulla Singh, Satwari, Jammu-18000373** as **Career Counseling Officer** in the Employment Department in the Pay Level-6 (Rs.35400-112400) on temporary basis, with immediate effect:-


The appointee shall report to Directorate of Employment, J&K, 2nd Floor Auqaf Complex, Gandhi Nagar, Jammu within a period of 21 days from the date of issuance of this appointment order. **"In case, appointee failed to join within the stipulated period of 21 days (twenty one) days from the date of issuance of the appointment order shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice".**

The appointment of the above candidate as Career Counseling Officer shall be governed by the terms and conditions laid down in SRO-202 dated 30.06.2015 read with S.O 192 and 194 dated: 17.06.2020 respectively.

B) *The appointee shall be allowed to join only on production of the following certificates in original:*

- i) Academic/Technical Qualification Certificates.
- ii) Matriculation /Date of Birth Certificate.
- iii) Health Certificate from the concerned Chief Medical Officer of the District.
- iv) Permanent Resident Certificate issued by the Competent Authority.
- v) Certificates from the District Industries Centre (DIC), and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee(s).
- vi) Relevant category certificate.

B) *The appointment of above candidate, as Career Counseling Officer in the Employment Department shall further be subject to the following conditions:-*

- iii) The appointee shall give an undertaking to the effect that in case adverse report about her Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, She shall have no right to claim her appointment as Career Counseling Officer and her appointment, as such, shall be deemed to have been cancelled ab-initio;
- iv) Verification / genuineness of the qualification, reserved category certificate and recognition of the Institutes from the concerned issuing authorities.

The salary of the appointee shall not be drawn and disbursed till satisfactory reports as detailed at (A) and (B) above are not received.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

The inter-seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Service Selection Board.

The appointment shall be subject to outcome of the writ petition (s) if any, pending before Competent Court of Law.


