In case of failure of any of these appointee(s) to join within the stipulated period, his/her appointment shall deemed to have been cancelled without any further notice.

The appointment of the above candidates as Junior Assistant shall be governed by the terms and conditions as laid down under SRO-202 dated 30.06.2015.

A) The appointee(s) shall be allowed to join only on production of the following certificates in original:

- i) Academic/Technical Qualification Certificates.
- ii) Matriculation /Date of Birth Certificate.
- iii) Health Certificate from the concerned Chief Medical Officer of the District.
- iv) Permanent Resident Certificate issued by the Competent Authority.
- v) Certificates from the District Industries Centre (DIC), and District Employment & Counselling Centre to the effect that no loan under any self employment scheme has been taken by the appointee(s).
- vi) Relevant category certificate.

B) The appointment of above candidate(s), as Junior Assistant in the Employment Department shall further be subject to the following conditions:-


- i) Each appointee shall give an undertaking to the effect that in case adverse report about his Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, in that case He/She shall have no right to claim his appointment as Junior Assistant and his appointment, as such, shall be deemed to have been cancelled ab-initio;
- ii) Verification / genuineness of the qualification, reserved category certificates and recognition of the Institutes from the concerned issuing authorities.

The salary of the appointee(s) shall not be drawn and disbursed unless the satisfactory reports as detailed (A) and (B) above are received in their favour.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by these appointee in the selection list prepared by the J&K Service Selection Board.

The appointment shall be subject to outcome of the writ petition (s) if any, pending before Competent Court of Law.
