Subject: Cancellation of appointment of Junior Scale Stenographers.


1. Whereas, on the recommendation of J&K Services Selection Board vide no. SSB/Sel/Secy/2017/10464-70 dated 09.10.2017 and the approval conveyed by the Administrative Department vide No. L&E/Emp/35/2014 dated 09.11.2017, Eight (08) candidates were appointed as Junior Scale Stenographers in the Employment Department vide Order No;336-ED of 2017 dated: 15.11.2017; and
2. Whereas, all the appointees were intimated through registered post to report to the Directorate of Employment, Auqaf Complex Gandhi Nagar, Jammu within a stipulated period of 21 days from the date of issue of this order; and
3. Whereas, the appointment order was also published in the leading news papers of the State for information of all the concerned appointees; and
4. Whereas, out of the 08 selected candidates, only 02 candidates joined in the Department and the following Six (06) candidates did not turn up for joining.
