- 2) Ms. Shaista Parveen D/O Mohammad Ramzan R/O Bhalessa Tehsil Gandoh District Doda OM category.

The appointment of above candidates shall be on the following terms and conditions as laid down under SRO; 202dated: 30-06-2015:-

- 1) The appointees shall be initially on probation for a period of five years and after completion of five years their services shall be declared as permanent.
- 2) The appointees shall have to necessarily work for a period of five years on the post against which they have been appointed and such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years;

In case any appointee is adversely reported upon by the verifying agency i.e. CID, he shall have no claim to hold the post and the appointment shall stand automatically cancelled without any further notice.
