**Subject: Appointment of Class-IV in District Ramban.**

**Reference: Letter No: DE&CC/Rbn/.2017-18/10-11 dated: 10-04-2017**

Consequent upon the recommendations of the District Level Recruitment Committee, sanction is hereby accorded to the appointment of following two candidates as Orderlies in the pay scale of 5200-20200 + Grade Pay Rs: 1300/- in District Employment & Counselling Centre, Ramban:-

- 1) Shri Mohd. Hasham Malik S/O Mohd. Sadiq Malik R/O Ward No: 03 Batote District Ramban under Open Merit category;
- 2) Shri Ajay Kumar S/O Tirath Ram R/O Pouni Billwat Ramban under SC category (S.No: 01 of the waiting list under SC category, as Shri Ramveer Singh S/O Om Raj R/O Karyan Seri Doda who was selected under SC category has been selected in District Doda also)

The appointment of above candidates shall be on the following terms and conditions as laid down under SRO; 202 dated: 30-06-2015:-

- 1) The appointees shall be initially on probation for a period of five years and after completion of five years their services shall be declared as permanent.
- 2) The appointees shall have to necessarily work for a period of five years on the post against which they have been appointed and such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years;
- 3) During the period of first five years, the appointee shall be entitled to the minimum of scale of pay alongwith the grade pay applicable to the post against which he is appointed;
- 4) Every appointee after completion of first five years period on probation shall be entitled to fixation of pay in the time scale of pay applicable to the post against which he is appointed.
- 5) The appointees shall be entitled to Annual increments, Dearness Allowances, House Rent Allowance and City Compensatory Allowance after successful completion of their five years' service on consolidated salary;

- 6) The appointees shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of their appointment itself;
- 7) The seniority of persons appointed under these rules shall reckon from the date of appointment;
- 8) The period spent on probation/consolidated salary shall also reckon for purpose of qualifying services of these appointees for benefits admissible provided under rules.
- 9) The appointees shall be allowed to join on production of following certificates in original:-

- a) Date of Birth certificate
- b) Permanent Resident certificate
- c) Category certificate, if any issued by the competent authority
- d) Qualification certificate
- e) Character certificate
- f) No Demand certificate from concerned DE&CC & DIC
- g) Medical certificate

10) The salary of the appointee shall be drawn and disbursed only after receipt of Character and Antecedents verification report from the verifying agency. In case any appointee is adversely reported upon by the verifying agency i.e. CID, he shall have no claim to hold the post and the appointment shall stand automatically cancelled without any further notice.

11) The appointees shall join in the Office of District Employment & Counselling Centre, Ramban within a period of 21 days from the date of issuance of the order failing which the appointment shall automatically get cancelled without any notice and next candidate in order of merit in the waiting list shall be appointed.
