## **Subject: Cancellation of appointment of Junior Assistants.**

1. Whereas, on the recommendation of J&K Services Selection Board vide no. SSB/Sel/Secy/2017/2017/9311-17 dated 18.09.2017 conveyed by the Administrative Department vide letter No. L&E/Emp/10/2013-I dated 22.09.2017, four (04) candidates were appointed as Junior Assistants in the Employment Department vide Order No;289-ED of 2017 dated: 05.10.2017; and
2. Whereas, all the appointees were intimated through registered post to report to the Directorate of Employment, 38-A, Hotel City Centre, Sumanderbagh, Exchange Road, Srinagar within a stipulated period of 21 days from the date of issue of this order; and
3. Whereas, the appointment order was also published in the leading news papers of the State for information of all the concerned appointees; and
4. Whereas, out of the 04 selected candidates, only 02 candidates reported for joining in the Directorate of Employment within the stipulated period of 21 days i.e upto (25.10.2017) and the following two candidates did not turn up for joining.
