**2) Terms & conditions:-**

- Tenders should be addressed to the **Director Employment J&K, Auqaf Building, Gandhi Nagar, Jammu** and must reach by registered post/speed post or in person on or before 09.02.2015 upto 3:00 PM. The tenders shall be opened on the same day at 4:00 PM in presence of the bidders who wish to be present.
- The sealed cover (Bid) must be superscribed "**Tender for Generator**". The address of Bidder be clearly mentioned on the envelop alongwith contact number.

3. The bidders shall have to deposit earnest money worth Rs.5,000.00 (Rs. Five thousand only) in the shape of CDR pledged to the **Deputy Director Employment (Central)** along with the Bid. CDR of unsuccessful bidders shall be returned within 30 days.
4. The rates quoted by the firms should be free from any cutting, over-writing whatsoever, and such tender shall be liable for rejection even if all other conditions are fulfilled.
5. One Genset is to be installed in the office of the Directorate of Employment, Gandhi Nagar Jammu and another at Directorate of Employment at Srinagar.
6. The successful bidders shall have to supply and install the Gensets within one week from the placement of supply order.
7. The validity of the tender rates quoted by the tenderer shall be six months from the date of Bidding. The bidders may bid for only one or both the generators.
8. The tenders received after the prescribed time and date will not be accepted.
9. The tenderer shall have to give full details with regard to guarantee/warranty and service agreements.
10. 100% payment shall be made after successful installing of the Generator and subsequent verification by technical experts.
11. Tender accepting authority reserves the right to accept or reject any or all the tenders before or after their opening without assigning any reason.
12. The rates should be inclusive of the installation charges and successful bidder shall install the Genset within a period of seven (07) days from the date of placement of supply order.
